Problems and Optimization Countermeasures in Material Management and Financial Accounting of Wind Power Enterprises

The materials in wind power enterprises refer to the large parts (the large parts mentioned here generally refer to the parts with high unit price and high maintenance cost), spare parts (the spare parts mainly refer to the parts that provide corresponding replacement services for the fixed assets mentioned above) and instruments associated with the booster station, power supply lines and other fixed assets. Generally, the materials needed by wind power enterprises are placed in the wind farm booster station, and the personnel responsible for daily maintenance also need to take into account the relevant management of the warehouse, whose main work content is the procurement of materials, material quality inspection, storage, application for scrapping, and so on. At the end of each month, the management personnel will report the corresponding material management data to the financial department, and the department will receive the information Door responsible for the overall value of the accounting work.

2. DEFICIENCIES OF MATERIAL MANAGEMENT AND FINANCIAL ACCOUNTING IN WIND POWER ENTERPRISES

Nowadays, most wind power enterprises take project innovation, safe production and engineering construction as the key content of their market share, and the corresponding material management and financial accounting work as the internal auxiliary force to ensure the operation of the enterprise. 2.1 Warehouse management personnel have multiple positions and poor professional level

However, the actual situation is that these materials have not been obtained. In the end, there is a large error in the information of material delivery and storage, which increases the difficulty of financial accounting, and the book is not authentic. The inventory form lacks the confirmation and signature of representatives of all parties involved in the inventory. For example, some large parts replaced by faulty fan repairs have not been eliminated from fixed asset accounts, resulting in inflated corporate asset values. There are many factors leading to this situation, mainly two, one is that the staff of material management department did not realize the impact of the replacement of large parts on the fixed assets accounts, did not pass this matter to the financial department. Second, the timeliness of information transmission between different departments is poor, and there is a lack of real-time communication, which leads to inaccurate accounting, inconsistency between material management and value, and difficult inventory work.

In the traditional classroom of educational psychology, teachers play a major role in teaching activities by following a certain syllabus and taking a certain teaching goal as the leading factor. 2.6 The development process of material management informatization is slow

Some wind power enterprises have not even introduced the network, which leads to the sharing of wind farm information, poor effect with the financial docking work, the physical management and value management of material management are not synchronized, which leads to the lack of accurate reference in the later inventory work, and the inventory is difficult or even impossible. No Conducive to the effective management of enterprise assets. As mentioned above, the traditional teaching of educational psychology is more about one-way knowledge transfer from offline teachers to students. The development of massive open online course has realized the integration of various teaching resources, teaching modes and teaching means. 3. OPTIMIZATION WAY OF MATERIAL MANAGEMENT AND FINANCIAL ACCOUNTING OF WIND POWER ENTERPRISES

As for the above problems, the management personnel of relevant departments of wind power enterprises should pay attention to them and optimize the material management and financial accounting based on the situation of the enterprises themselves, so as to improve the benefits of wind power enterprises. The traditional syllabus of educational psychology is based on the environmental characteristics of campus classroom teaching, and its compatibility with massive open online course model is not satisfactory. Therefore, it is necessary to construct a new knowledge system of educational psychology that is suitable for massive open online course. The specific methods are as follows:

3.1 Do a good job in material management publicity, and conduct financial knowledge training

The material management and financial accounting of most wind power enterprises have been gradually improved. The problem mainly lies in the personnel's understanding and application of financial knowledge and enterprise system. To this end, wind power enterprises can increase the publicity of material management, so that every material management personnel understand the importance of enterprise material management, and strengthen the management of details in the daily work. Enterprises can also periodically trained the staff of material management and finance department, explained the material management system and financial accounting rules in detail, and gave examples of frequently encountered problems, such as inventory procedures, filling in and transferring documents of materials in and out of storage, etc. After the explanation of the training theory, practical operation is added, with on-site assessment as the main part. Through the assessment, the trainers find out the problems existing in the work of the trainees and give guidance, so as to improve the working skills of the staff.

3.2 Strengthen the comprehensiveness and rationality of budgeting

Material purchasing personnel of wind power enterprises should be in the last year of the actual procurement costs and costs under the premise of comprehensive understanding, accurate material procurement budget for the New Year, at the same time, also need to communicate and coordinate with the functional management department of the enterprise in a timely manner, the development of a comprehensive budget management system, through the system constraints, to achieve the enterprise goal - budget formation - monitoring and adjustment Whole process control of the integral link. In addition, material management is a kind of control on the surface of enterprise production materials, but its fundamental purpose is to create more profits for enterprises to serve, so the premise of its budget should be based on enterprise profits. To this end, material management personnel to the budget for scientific and reasonable detailed subdivision, and the material procurement budget to the specific implementation of each month, each quarter, in order to maximize the budget to avoid the problem of going through the motions, so that the budget effectively play its own role, so that the resources of the enterprise can play its maximum role, realize the effective allocation of resources, and ultimately protect Hindering the economic benefits of enterprises.

In addition, once the material budget is established, it must be strictly implemented. At the same time, the budget analysis system should be established and improved, so as to conduct timely inspection and tracking of the prefabrication and implementation. At the same time, the financial department of the enterprise should also conduct timely analysis of the budget implementation progress, and on this basis, set the budget red line, so as to provide information and data reference for the decision-making of the enterprise management. As for the problems that do not meet the expectations in the implementation of the budget, the reasons should be found and dealt with as soon as possible, so as to avoid the problem of illegal expenditure.

Strictly implement the material management system and incorporate the system implementation results into the performance appraisal. In the material management work, the standards and requirements of the system should be strictly followed Do, and continue to increase before, during and late material management efforts, improve the level of material management. For example, there are many kinds of materials in the wind farm and their prices are high, so it is necessary to do a good job of inventory in advance. Before the inventory, it is necessary to make a reasonable inventory plan and implement the responsibilities of relevant staff; In the process of inventory.

3.4 Improve the information level of material management

Material management information has a remarkable effect on improving the standardization and effectiveness of material management. Wind power enterprises have relatively high requirements for materials, so in the management, it is necessary to effectively classify equipment and accessories according to their categories and models, and store them in the computer system to provide help for later use and application. At the same time, through the application of information technology, the uploaded material information can be timely transmitted to the financial management department, which has a significant role in simplifying the approval process and improving the operation efficiency of warehouse documents. The construction of massive open online course of educational psychology needs to follow certain norms, no matter from the teaching rules of educational psychology courses or from the development and application of Internet information technology. On the one hand, we should follow the law and experience formed in the long-term teaching of educational psychology and conform to the curriculum characteristics of educational psychology; What's more, it is necessary to follow the general norms of massive open online course in the development and application of Internet information technology, mainly including media format requirements, basic information coding rules, production process and requirements, resource access and information security. 3.5 Make inventory detail cards

Implement the management mode of special personnel and assign responsibility to individuals. In order to later check accounts, increase the utilization of materials allocation. Massive open online course plays a powerful role in improving the teaching effect of educational psychology, but there is still a certain gap between massive open online course and high-quality educational psychology teaching services, so it is necessary to build diversified learning methods to supplement it. 3.6 Improve the material ledger

Summarize inventory at the end of the month. Submit the warehouse summary statistical table to the relevant departments for verification, and prepare the material reconciliation table after confirmation, which is signed by the management personnel for confirmation. In recent years, especially under the influence of the epidemic, education is in transition, online education is rising rapidly, and online teaching platform is becoming more and more perfect. Massive open online course has gradually become the trend of mobile learning in the future. However, at present, most of massive open online course's educational psychology is taught on the pc side, which has certain space and time constraints. In the traditional teaching of educational psychology, teachers often spend a lot of time preparing for the course filing and case collection, and then teachers give lectures in the course, with little communication between students and teachers. But now with massive open online course as the "communicator", the way of preparing lessons for teachers has changed, and the workload of preparing lessons is less. In this way, it is more conducive to the interaction between teachers and students. What' s more, massive open online course has also strengthened mutual assistance and learning between students, forming a good atmosphere of teacher-student communication and student mutual assistance.

4. CONCLUSION

In a word, in the daily material management work of wind power enterprises, its management and financial accounting have a certain degree of problems, and these problems have been a threat to the asset management security of enterprises. Therefore, we should start from our own practical work, formulate a scientific management system, effectively solve the problems in material management and financial accounting, and then better escort the development of enterprises. In summary, massive open online course has broken the traditional classroom education mode of educational psychology, let knowledge go out of the classroom and come online, so that the target group can enjoy high-quality education services anytime and anywhere, which greatly improves the teaching effectiveness and quality. In the next step, we should further deepen the application of the new achievements of Internet information technology in the teaching of educational psychology, constantly adhere to and develop the teaching mode and system of educational psychology in massive open online course, make contributions for a long time, promote the development of education with the innovation of science and technology, and promote the improvement of national quality with the development of education.
