"Er" describes an extremely tragic snowstorm disaster: when the wind and snow comes, the fragility of life in nature is fully revealed, and the only thing they can do is strive to protect yourself, any rebellion against Feng Xue will be severely and completely destroyed. In this merciless snowstorm, the reindeer on which the Ewenki people depended also suffered heavy losses, casting a heavy shadow over their lives. This is the experience of people living in the borderlands of a more immediate and cruel existence.
